TRANSFERS OF RECORDED OWNERSHIP

CERTIFICATE OF REGISTRATION

The certificate of registration is issued by The American Hanoverian Society (AHS) upon application of the breeder/owner. All persons applying for registration or transfer of ownership of a horse are subject to the society's *Corporate Bylaws and Rules of Registration*.

Upon sale of the horse, the AHS owner(s) of record must convey the certificate of registration to the purchaser(s). It is the responsibility of the new owner(s) to effect a transfer of ownership with The American Hanoverian Society by returning the following to the AHS office: 1) A signed and dated transfer of ownership form or an executed bill of sale including the previous owner's signature; 2) A copy of the original registration papers showing both sides; 3) The appropriate transfer of ownership fees and/or membership fees. Note: the transfer fee for non-members is double the fee for AHS members. Upon completion of the transfer, the AHS office will send the new owner a sticker which should be applied on the back of the registration papers.
